

Pursuant to Act No. 283/1992 Coll., on the Czech Academy of Sciences, as amended, Act No. 341/2005 Coll., on public research institutions, as amended, and in accordance with the Statutes of the Czech Academy of Sciences dated 24 May 2006, the Czech Academy of Sciences hereby issues

**the Full Text of the Foundation Deed of
the Institute of Philosophy of the Czech Academy of Sciences
(in Czech “Filosofický ústav AV ČR, v. v. i.”)**

dated 28 June 2006 (English version dated 20 December 2006), as amended by Addendum No. 1 dated 7 December 2007:

I

(1) The Institute has been established by the resolution of the first session of the Presidium of the Czechoslovak Academy of Sciences (hereinafter the “CSAS”) held on 10 January 1990 effective from 1 February 1990, under the name the Institute of Philosophy of the CSAS. Under section 18 (2) of Act No. 283/1992 Coll., the Institute became an entity within the Czech Academy of Sciences as of 31 December 1992. By the resolution of the twenty-third session of the Academy Assembly of the Czech Academy of Sciences held on 17 December 2003, the Institute for Classical Studies of the Czech Academy of Sciences, identification number 68378106, located in Prague 1, Na Florenci 1420/3, was consolidated into the Institute of Philosophy of the Czech Academy of Sciences as of 1 January 2004.

(2) Under Act No. 341/2005 Coll., the legal status of the Institute of Philosophy of the Czech Academy of Sciences was transformed from a state contributory organisation into a public research institution (abbreviated in Czech as “v. v. i.”) from 1 January 2007.

II

(1) The Institute of Philosophy of the Czech Academy of Sciences (hereinafter the “IPL”) is established for an indefinite period of time as a legal entity, identification number 67985955, headquartered in Prague 1, Jilská 361/1, postal code 110 00.

(2) The founder of the IPL is the Czech Academy of Sciences, an organisational body of the state, identification number 60165171, headquartered in Prague 1, Národní 1009/3, postal code 117 20.

III

(1) The purpose for which the IPL has been established is to carry out scholarly research in the field of philosophy, to contribute to the utilisation of its research results, and to provide a research infrastructure.

(2) The principal activity of the IPL is scholarly research in the fields of philosophy and related humanities, particularly logic, classical and medieval studies, Comeniology, the theory of science and global studies. The IPL contributes to raising the level of knowledge and education and to utilising the results of scholarly research in practice. It acquires, processes and disseminates scholarly information and issues scholarly publications (monographs, journals, proceedings, etc.). It provides scholarly assessments, professional opinions and recommendations, consulting and advisory services. In cooperation with universities, the IPL carries out doctoral study programmes and provides training for young scholars. Within the scope of its activity, the IPL promotes international cooperation, including the organisation of joint research projects with foreign partners, participation in exchange programmes for scholars and the exchange of scholarly information, as well as the preparation of joint publications. The IPL organises scholarly meetings, conferences and seminars at the national and international levels and provides the infrastructure for research, including accommodation for its employees and guests. It pursues its aims both independently and in cooperation with universities and other research and professional institutions.

IV

(1) The director, the board and the supervisory board are the bodies of the IPL. The director is the statutory body of the IPL and is entitled to act as a deputy for the IPL.

(2) The basic organisational units of the IPL are working groups, divisions and centres responsible for scholarly research, and furthermore, the journal editorial office, the editorial department, the library of the Institute of Philosophy, the library of the Division for Classical Studies, and a service department responsible for provision of the infrastructure.

(3) The detailed organisational structure of the IPL is regulated by the rules of organisation issued by the director after being approved by the board.

V

(1) The following interests to the undermentioned real estate, which is owned by the Czech Republic, and to which the Czech Academy of Sciences has the right of management is provided to the IPL:

- a) the interest of 1/3 in the building registration number 236, located on the land plot No. 381 in the cadastral area of Staré Město (book value of the building 17 337 534,89 CZK),
- b) the interest of 1/3 in the land plot No. 381 in the cadastral area of Staré Město (book value of the land plot 1 339 600 CZK),

- c) the interest of 1/3 in the building registration number 352, located on the land plot No. 380/1 in the cadastral area of Staré Město (book value of the building 15 569 964,83 CZK),
- d) the interest of 1/3 in the land plot No. 380/1 in the cadastral area of Staré Město (book value of the land plot 2 284 800 CZK),
- e) the interest of 1/3 in the building registration number 361, located on the land plot No. 380/2 in the cadastral area of Staré Město (book value of the building 7 560 734,51 CZK),
- f) the interest of 1/3 in the land plot No. 380/2 in the cadastral area of Staré Město (book value of the land plot 1 302 200 CZK),

including component parts and appurtenances.

(2) With the provided real estate obligations are passing onto the IPL. The obligations are given in Appendix No. 1, which is an integral part of the Foundation Deed of the IPL.

(3) The right of co-ownership to the provided real estate shall be acquired by the IPL by recording the title into the Land Register of the Czech Republic.

VI

This Foundation Deed shall be effective as of 7 December 2007.
