

## **Announcement of a public selection procedure for filling the position of Director of the Institute of Philosophy of the Czech Academy of Sciences, PRI (FLÚ AV ČR, v. v. i.)**

The Board of the Institute of Philosophy of the Czech Academy of Sciences (IP CAS) announces a public selection procedure for the position of Director of the Institute.

### **Requirements:**

- University education and scholarly qualification in one of the research fields within the field of IP CAS;
- academic degree and/or scholarly qualification (i.e. CSc., Ph.D. or equivalent, and/or DSc./Doc./Prof.);
- relevant research and publication activity;
- organisational and managerial skills and experience in research management;
- active spoken and written knowledge of Czech and English
- moral integrity;
- legal capacity\*;
- integrity (no criminal record) in accordance with § 17 paragraph 4 letter b) and c) of Act Nr. 341/2005 Coll., on public research institutions, as amended;
- meeting of the conditions in accordance with Act Nr. 451/1991 Coll., which establishes certain additional prerequisites for the performance of certain functions in state bodies and organisations of the Czech and Slovak Federative Republic, the Czech Republic, and the Slovak Republic, as amended (does not apply to an applicant who is not a citizen of the Czech Republic).

The Director cannot be a member of the management or supervisory bodies of legal entities operating a business activity and cannot participate in business of legal entities operating in the area that is the subject of the Institute's activities. The above-mentioned restriction does not apply to the management of one's own property (§ 17, paragraph 6 of Act Nr. 341/2005 Coll.).

**Expected term of office:** from 1 October 2023 to 30 September 2028.

### **Materials Required for the application:**

- CV;
- overview of previous work experience, including references;
- list of most significant publications and other research outputs;
- your concept about IP CAS' management and the direction of its activities, including its future development (submitted in Czech with a maximum length of 30 standard pages);
- documents on attained university education and attained scholarly qualifications;
- document from the Register of Criminal Records not more than 3 months old\*;

- an affidavit (sworn declaration) of no criminal record in accordance with § 17 paragraph 4 letter c) Act Nr. 341/2005 Coll.\*

\* An applicant who is not a citizen of the Czech Republic is required to attach an affidavit indicating the fulfilment of the conditions according to § 17 paragraph 4 of Act Nr. 341/2005 Coll.

The selected applicant shall submit proof of the meeting of the conditions in accordance with Act Nr. 451/1991 Coll. to the President of the Czech Academy of Sciences no later than the date of appointment to the position of Director of the Institute.

Applicants who will be invited to a personal interview will demonstrate their knowledge of the current state and scholarly activities of IP CAS (based on publicly available information) and present their concept concerning its future activities, development and direction.
